## Thorneloe Memorial Bursaries/Thorneloe Faculty and Governors Bursaries:

Several bursaries in memory of Thorneloe students (Elizabeth Pentland, Brian Clark, Louis Larocque, Colin Elliot, Ronald Trolove), as well as bursaries established by the Faculty and Governors, are awarded to students who are living in residence at Thorneloe University or who are taking a course from Thorneloe University. Preference may be given to students who are also registered at Thorneloe University. The number and amount of such awards may vary annually, depending upon funds available. Awards are made on the basis of good academic standing and financial need. Some funds are restricted to students who have resided in Ontario for twelve months prior to beginning university (OSAP policies on residence apply).

**Application through Thorneloe University is required, and the awards are made upon recommendation of the Provost of Thorneloe University once per term.**

## The Hillary Afelskie Memorial Bursary:

This bursary was set up in memory of Hillary Afelskie, a Thorneloe University resident who was tragically killed in a traffic accident on January 4, 2012. The bursary is awarded annually to a female resident at Thorneloe with a demonstrated financial need, good academic standing, and record of volunteer involvement in community, non-profit, or charitable activities. ***An application letter is required that articulates these qualifications.***

**Application through Thorneloe University is required, and the awards are made upon recommendation of the Provost of Thorneloe University.**

## The Ted Evans Memorial Bursary:

Donated by the Evans family and friends in memory of Mr. Ted Evans, an active Sudbury community minded businessman. This bursary is awarded annually to a full-time undergraduate or a graduate student on the basis of good academic standing and financial need, who is a permanent resident of Northern Ontario. ***Applicants must show indication of active community work either in their high-school education (if in their first year) or during their studies at Laurentian University.*** Special consideration will be given to students studying in a programme of business such as Commerce, Economics, or Business Administration. It will be an asset to have taken courses at Thorneloe University or to be living in Thorneloe Residence. Mr. Evans was a member of the Board of Governors of Thorneloe University for many years.

**Application through Thorneloe University is required, and the awards are made upon recommendation of the Provost of Thorneloe University.**

## Church of the Resurrection Theology Bursary:

The Church of the Resurrection Theology Bursary has been set up by the Church of the Resurrection, Sudbury, to assist students of theology who have a vocation for pastoral leadership in the Anglican Church. Funds will be drawn from the interest on the endowment, and the value of the award will vary from year to year, depending on the interest available, the number of qualifying applicants, and the discretion of the administrators of the fund. Recipients must be Canadian citizens, Permanent Residents or Protected Persons who are enrolled in a provincially-assisted postsecondary program and who meet provincial residency requirements as set out in the Ontario Student Assistance Program's 2005-06 Student Eligibility and Financial Need Manual. Awards will be made to students who have demonstrated financial need and are in good academic standing. ***Special consideration will be given to students who are from the deanery in which Sudbury is located; or, failing that, who are from the Diocese of Algoma; or, failing that, are from a diocese of the Council of the North.***

**Application through Thorneloe University is required, and the awards are made upon recommendation of the Provost of Thorneloe University once per term.**

### **The Order of St. Lazarus Bursary in Ecumenism Bursary:**

The Order of St. Lazarus Bursary in Ecumenism has been set up to assist annually students at Laurentian University who are majoring in **Religious Studies** and who have taken, within the past two academic years, at least 3 credits of Religious Studies at Thorneloe University. Funds will be drawn from the interest on the endowment, and the value of the award will vary from year to year depending on the interest available. Recipients must be Canadian citizens, Permanent Residents or Protected Persons who are enrolled at Laurentian University and who meet provincial residency requirements as set out in the Ontario Student Assistance Program's 2005-06 Student Eligibility and Financial Need Manual. Awards will be available to students, regardless of denominational affiliation, who have demonstrated financial need and are in good academic standing. A recipient of this award will be deemed ineligible to receive this award a second time, unless there are no other qualified applications.

***Applications must be accompanied by a 1500 word essay on some aspect of ecumenism.***

**Application through Thorneloe University is required, and the awards are made upon recommendation of the Provost of Thorneloe University once per term.**

### **Grace Foundation Bursary:**

This bursary is awarded annually to full-time or part-time students who are within the geographic boundaries of the Anglican Diocese of Algoma. They need to be enrolled in either a Theology program through the School of Theology, or specializing or majoring in Religious Studies at Laurentian University and have completed, or be currently enrolled, in at least one Religious Studies course at Thorneloe University. Students must be actively involved in their local church, with preference given to Anglican students; ***applicants are required to include a letter with the bursary application outlining this local church involvement and their active Christian faith.*** In addition, applicants must demonstrate good academic standing and a financial need.

**Application through Thorneloe University is required, and the awards are made upon recommendation of the Provost of Thorneloe University.**

### **The Ernie Checkeris Memorial Bursary:**

This bursary has been established by family and friends in memory of Ernie Checkeris. Ernie was a founder and long-time supporter of Thorneloe University. He was Board Chair and served as Chancellor from 2001 to 2010. Ernie also served as a public school board trustee from 1945 to 2000. This bursary is awarded annually to a ***Rainbow District School Board graduate\**** who has a demonstrated financial need and is in good academic standing. Preference will be given to a student who has taken courses at Thorneloe University. Students can apply for the bursary through Thorneloe University. The award will be granted once per year upon the recommendation of the Provost. ***\*Proof of high school diploma required.***

**Application through Thorneloe University is required, and the awards are made upon recommendation of the Provost of Thorneloe University.**
